

Taxation (Tax Exemption) and Residence Certificates Obtained at Municipal Government Offices

Documents obtained at municipal government offices are indicated in the table below.

Check the documents according to "Relationship of recognized person from the perspective of the insured person" and obtain the document at your municipal government office.

When obtaining these documents, the procedure will go smoothly if you present the following issuance request at the service counter of your municipal government office.

- Present "Issuance Request 1" when obtaining a Taxation (Tax Exemption) certificate.
- Present "Issuance Request 2" when obtaining a Residence Certificate.

Please follow the instructions of the person at the issuing service counter after presenting the request.

健康保険組合の被扶養者認定の申請にあたり、同居・別居の証明を使用目的として世帯全員の「住民票」の交付を申請します。

「住民票」は、続柄や筆頭者を省略することなく、必ず世帯全員を表記した個人番号（マイナンバー）の記載のないもので交付をお願いします。
